# Why are you seeking your office?

Expanding our current transit system by developing and implementing an expansive bus rapid transit system and eventually bringing rail into Gwinnett County are all optional transit choices that are needed to attract more tech jobs, improve commuter service, and ease traffic congestion in Gwinnett. The economic benefits of brining efficient transportation to Gwinnett County is paramount.
