### Why are you seeking the office?

### What is the proper role of a judge in interpreting the laws and Constitution?

Judges do not legislate. A good judge will not "interpret" laws or the Constitution, but rather seek to apply the law and the Constitution to the unique facts and circumstances of each case before him or her. No matter my personal opinion of any law, it's not up to me, as a Judge, to change it. The rule of law and the words of the Constitution are not changeable in a courtroom –only the facts of each case are different, and Judges must apply the laws to the facts, impartially, fairly and consistently.

# What in your life experience makes you believe that you would be a good Judge?

A good Judge must be patient. In addition to being the only candidate with experience in civil and criminal cases, representing both plaintiffs and defendants, I have served as a foster parent to Gwinnett's children, am the mother of a teenage daughter, and am responsible for the education and safety of all the students at Leadership Preparatory Academy. I tell people I have 478 children and one of my

own! I wouldn't be able to take on any of those roles successfully without a lot of patience.

## What do you think are the attributes of a good Judge?

Humility and patience, a commitment to fairness, the ability to consider all sides of every argument, the ability to make tough decisions, and a deep understanding that "justice" only exists when it is applied fairly and consistently to every person who interacts with the courts.

Born in Milwaukee, Wisconsin and attended the University of Wisconsin, Madison, for my Bachelor's in Business Administration and my Juris Doctorate. Moved to Gwinnett County in 1996, and have practiced law here ever since. My husband, daughter, and I live here.
