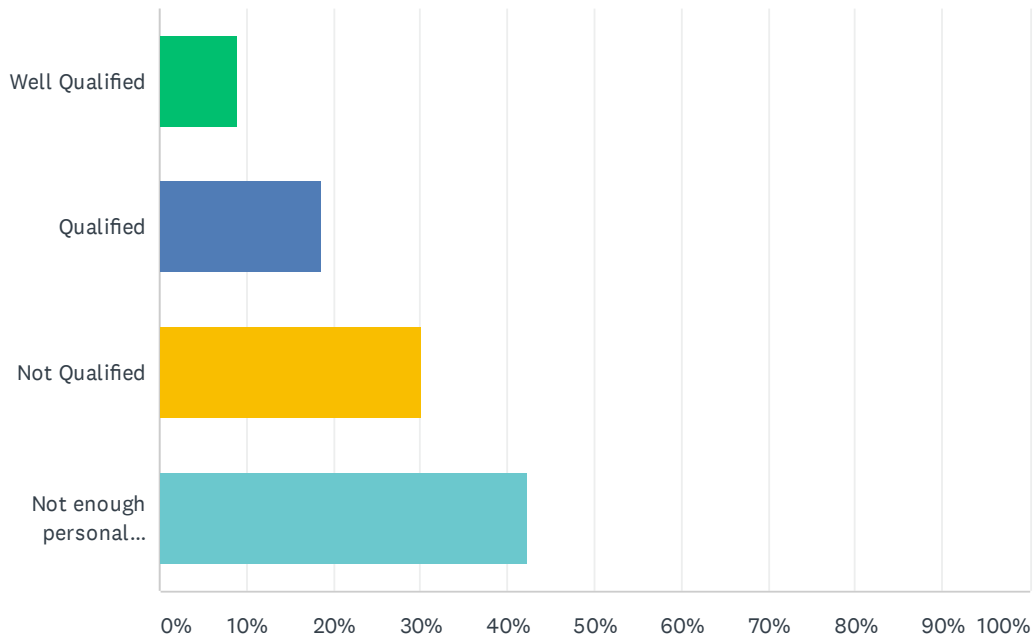


Q1 Based on your personal knowledge of Tamela Adkins, how would you classify her judicial qualifications?
