## AMENDMENT TO PETITION FOR ATTACHMENT OF CRIMINAL CONTEMPT

Now comes the Honorable Ronda Colvin Leary, Judge, Gwinnett State Court, Division IV, (hereinafter referred to as the "Court") and files this Amendment To Petition For Attachment Of Criminal Contempt against the Respondents, Brian W. Whiteside, Solicitor-General of the Gwinnett State Court (hereinafter referred to as the "Solicitor-General"), and shows as follows:

1.

OCGA § 15-18-66(a)(1) provides: "(a) The duties of the solicitor general within their respective counties are: (1) To attend each session of the state court when criminal cases are to be heard unless excused by the judge thereof and to remain until the business of the state is disposed of ...".Further, OCGA § 15-18-74(b) provides: "(b) If a solicitor general fails to attend court as required by law without just cause the solicitor general is liable to be fined \$50.00 for each failure, to be retained out of the solicitor general's salary." The Solicitor-General failed to attend the

Criminal Arraignment Calendar on January 3, 2022, at 9:00 am in GJAC Courtroom 3E. as required by law without just cause, therefore, the Solicitor-General should be fined \$50.00 for each failure, to be retained out of his salary. There were twenty-five(25) cases on the Criminal Arraignment Calendar and the Solicitor-General should be fined \$1,250.00 in addition to all separate and distinct punishments for contempt.
