## 1.Why are you seeking your office?

When I attended the 2018 Democratic Convention, John Lewis, who was known for creating "good trouble", gave a soul-stirring speech. He said that the Democratic Party needed some fresh blood, and it was time to pass the torch. I felt like he was talking directly to me. It was at that moment I decided that I was going to run for office. I was going to become the change I wanted to see in our state.

# 2. What do you expect to accomplish if elected?

I am a person before I am a politician. The people are who will elect me, so I prioritize their needs. I am not beholden to special interest groups or political parties. I am beholden to the people of the state of Georgia. In the words of Shirley Chisolm, I am "unbought and unbossed."

## 4.Pick any one issue. Expand on how you will address it.

To address the large number of uninsured Georgians, I strongly advocate for the expansion of Medicaid. Currently, non-disabled adults without dependent children are ineligible for Medicaid regardless of what their income is. This means there are several Georgians either below the poverty line or working poor who cannot be covered. According to the Kaiser Family Foundation, there are 260,000 Georgians who are in the

Medicaid coverage gap. They aren't eligible for Medicaid, and don't qualify for subsidies in the exchange. I will work with the Governor and other elected officials to make this expansion a reality. Healthcare is a right.

### 5. What are your ideas on curbing all the many area-wide shooting?

Common-sense gun laws need to be enacted. Additionally, the root causes of increased violence must be explored. Prices in Georgia are going up, but salaries aren't. Many are desperate and are trying to survive by any means necessary.

As Insurance Commissioner, I will use my platform to create educational and career opportunities for those who are often underserved and underrepresented in the industry.
